Rancho Santa Ana Botanic Garden (RSABG) has received limited funds to supplement the **cost of transportation and/or tour fees for Title I schools** that participate in RSABG Guided Tours and Programs. Distribution of funds will be determined by RSABG program staff based on this application. Total funding is limited to a maximum of \$500 per eligible school. Tour fees utilized will be credited to RSABG and transportation costs will be reimbursed to schools based on actual costs following completion of a guided tour or program. *If awarded, funds must be used by June 30, 2013.*
